Course Description

The course introduces the students to the basic theories of labor markets. It will emphasize the interaction between theory and empirical. The first part of the course is devoted to studying the labor demand decisions taken by firms in competitive markets, the supply decisions taken by rational workers, and the equilibrium outcomes in such markets. The second part of the course analyzes imperfect labor markets, and the last part covers other important topics in labor economics: human capital, wage inequality and discrimination.

Course Goals

Upon successful completion of this course, students will be able to:

- Have good mastery of knowledge about labor market and economics.
- Use the methods and tools of economic analysis as they are applied to the labor market.
- Apply these tools to current issues in the labor market today.

Your grade will be based on quizzes, homework, exams, and participation.

Exams (40%, 20% each):

For the five-week course, there will be two equally weighted exams. The exams must be submitted online by the deadline. Each exam, worth 200 points, will consist of a mix multiple choice-questions, essay questions and/or problems and applications.

Moreover, <u>some of the questions from the homework assignments will be included</u> <u>in the exams.</u> Each exam will determine **20 percent** of your final grade. In addition, there is a **time limit of 180 minutes or 3 hours** to complete each exam. Consequently, students must complete and submit each exam within **180 minutes**. Once students begin the exam, the clock begins to tick, and students will **not be able** to access the exam after the **expiration of 180 minutes**. Finally, the second exam will test students on the material covered after the first exam.

Each Exam is worth 20% of your class grade for a total of 40%.

Homework (20%):

For this five-week course, there will be four Homework Assignments. Each homework will consist of **50 points** for a total point of **200 points**.

More importantly, there is a 50% extra credit built into the total score of the homework. As a result, the total score of the homework will be multiplied by 1.5 to get the final actual score of the homework. The final actual score of the homework will be capped at 100%. For instance, given a maximum of 200 points available on the homework, if someone earns a total score of 133 points on the homework, her final actual score would be the full 200 points $(133 \times 1.5 = 200 \text{ points or } 100\%)$; if someone earns a total score of 120 points on the homework, her actual final score would be 180 points $(120 \times 1.5 = 180 \text{ points or } 90\%)$; if someone earns a total score of 107 points on the homework, his actual final score would be 160 points $(107 \times 1.5 = 160 \text{ points or } 80\%)$; if someone earns a total score of 93.5 points on the homework, his actual final score would be 140 points $(93.5 \times 1.6 = 140 \text{ points or } 70\%)$; finally, if someone else earns a total score of 150 points on the homework, her actual final score would be the full 200 points $(150 \times 1.5 = 225 \text{ points}, but capped at <math>200$ points or 100%).

Paper (30%):

You must write a paper, also called a term paper, concerning any labor topic of your choice. Your topic must be approved by the instructor before you can start working on it. The paper must be well-written and clear. The paper should present an idea or an event and discuss the current understanding of the situation.

The written paper must include the following basic requirements:

- 2. Thesis clearly stated in the introduction and/or referenced in the conclusion
- 3. Correct documentation style used in text
- 4. Citing evidence with a minimum of 10 sources

- 6. Works Cited/Bibliography or References accurate and correctly formatted
- 7. Paper meets minimum length standard (at least 500 words, excluding title and Works

Cited/Bibliography or References)

- 8. Paper meets maximum length standard (at most <u>2000 words</u> including title, abstract, references and appendix)
- 9. Includes an appendix for graphs, charts, tables, and pictures
- 10. Evidence of consistent and conscientious editing
- 11. Use of 12-point font (e.g., Times New Roman font), double spacing and page numbering
- (i.e., centered at the bottom of each page)
- 12. Demonstrates use of paraphrasing, direct, and indirect quotations in the paper

Term paper is worth 30% of your class grade.

⇒ Topic/Title of the term paper must be submitted online and by email for approval of the instructor by Monday of Week 2 by 11:59 am Beijing Time (Day 6 of the course).

- Abstract (i.e., Summary with expected outcome/result of the term paper) and Outline (i.e., Table of Contents) of the term paper must be submitted online and by email for approval of the instructor by Thursday of Week 2 by 11:59 am Beijing Time (Day 9 of the course).
- Final Report of the term paper must be submitted online by Monday of Week 5 by 11:59 am Beijing Time (Day 21 of the course).

Class Participation (up to 10% of total grade)

A student can earn points for active attendance, attentiveness in live orientation, involvement in class discussions, and attending the weekly review session.

This is an online class and there is <u>no formal class attendance</u>. Attendance will be measured by the student engagement and participation to the course material. Class Participation is an integral part of this course and of your education. Students must attend <u>online the weekly review session</u>.

Students are awarded 0.67% per chapter summary up to a maximum of 8% of your class grade (i.e., 0.67 point x 12 chapters or 8 points). The chapter summaries must be posted online on the Discussion Board by the deadline and will be available to all the students. The length of each summary must be 150 - 600 words. Moreover, if the length of the chapter summary is at most 15 - 149 words, students must highlight the PowerPoint of the chapter and submit it along with their chapter summary in order to earn full credit. You will be expected to interact with myself and fellow classmates through the online Discussion Board and during the weekly review session. You are welcome to ask me questions via email, but you will earn participation points only through online Discussions postings.

Late submission will adhere on the following late submission policy.

You will be allowed to make up work for full credit only under extreme circumstances (such as a documented, serious health-related emergency). *This make-up policy will follow this Late Submission Policy.*

Moreover, you will earn <u>0.4 point</u> for attending each weekly review session for a total of <u>up to 2 points of your class grade</u> (i.e., 0.4 point x 5 weekly review sessions or 2 points).

More importantly, you will earn <u>0.125% extra credit for class participation up to</u> <u>2% extra credit</u> by posting feedback about the chapter summaries from other fellow students and/or by posting any question/response/feedback about the course materials on the Discussion Board online. In addition, multiple posts within the <u>same</u> <u>discussion thread/topic</u> are potentially welcome, but will collectively count as only one post for <u>0.125% bonus point</u>. The <u>2% extra credit</u> for class participation will be added to the class grade.

The class participation is worth 10% of the class grade plus up to 2% extra credit for feedback about online postings from other students.

Attendance/Makeup Policy

Live Sessions

Students are not required to turn on their cameras or microphones. They are not required to ask or answer any questions. Moreover, students are required to attend the orientation live session and the weekly review sessions. Failure to attend these sessions will result of the <u>loss of ½ point per absence</u> deducted from the <u>10% for participation</u>.
